

Rome-Floyd Fee Reduction Application

Reduced Fee Frequently Asked Questions

1. What does the reduced fee cover?

It covers either 50 to 75% of the registration costs only.

2. How will the scholarship annual limit be awarded?

The annual limit will be awarded per household.

3. What can I use this reduction for?

It can be used for registration for all sports, by individual (not a whole team), camps and programs organized by the Rome-Floyd Parks and Recreation Department.

4. What is not an approved use?

It cannot be used for travel to an event (tournaments, meets, day trips), uniforms/ equipment for play or admissions to events. It cannot be used for rental of facilities or road races.

5. Do I have to be a resident of Floyd County to be eligible for the program? Yes, proof of residency in Floyd County for at least 6 months of the year is required with the application.

6. Do I have to apply every time I want to register my child for a sport?

No, application will be good for one year from the time of approval.

7. What if my income level changes throughout the year?

Depending on what level you are currently at, the amount awarded may change. If there is a significant change in your income, please notify Rome-Floyd Parks & Recreation Department.

8. Is my child automatically registered for anything once my application is approved? No, you still have to register during normal registration times.

Proof of residency for ALL persons who reside in the household. Applicants must reside in Floyd County for more than 6 months during the course of the year.
Three (3) most recent pay stubs for all income earners in the household.
Copy of other sources of income (if applicable) i.e: social security, private pension, unemployment and workers comp. etc.
Copy of your most recent federal tax return for each adult in the household.
